Market Recovery Rate

From June 1, 2024 through May 31, 2027 the \$.20 per hour allocation from the Union wage package will go to the Market Recovery Fund and may be allocated or re-allocated by the Union in its sole discretion between wages, welfare and pension.

Apprentice Pension/School Hours

From June 1, 2024 through May 31, 2027, which will then expire, the JATC will fund 100% of drywall apprentice pension contributions.

Taper Employers shall not be required to make any benefit fund contributions for time the apprentice attends school i.e., Pension Fund, Welfare Fund, JATC Fund, Industry Advancement Fund, Scholarship Fund, Joint Cooperation Trust Fund and Chicago Painters and Decorators Retirement Savings Fund.

WAGES AND BENEFIT DISTRIBUTION TO BE MADE AT THE DISCRETION OF THE UNION

The present rate of two (2) hours more pay per day for General Foremen, and one (1) hour more per day for Foreman and one half (1/2) hour more per day for Sub-Foreman, remains unchanged.

***(Article 19 Sec 1) during the period June 1, 2024 to May 31, 2027 each Employer shall contribute to the Midwest Wall and Ceiling Contractors (MWCC) Industry Advancement and Promotional Fund (IAF) .05 cents per hour on employees covered by this agreement in the rate approved by the MWCC and by the Union. If you have questions concerning this increase, please contact the MWCC.



DRYWALL FINISHERS APPRENTICESHIP WAGE SCALE

You are hereby notified that in accordance with the agreement entered into between **PAINTERS DISTRICT COUNCIL #14, and MIDWEST WALL AND CEILING CONTRACTORS** the following **DRYWALL FINISHERS APPRENTICE** wage scale is in effective as of **JUNE 1, 2024** based on Journeyperson rate of **\$53.05** per hour.

Pay Period	Percent of Journeyman Scale	Per Hour Rate
During 60 day Probationary Period	40%	\$21.22
61 days to 1000 Hours	50%	\$26.53
1001 to 2000 Hours	60%	\$31.83
2001 to 3000 Hours	70%	\$37.14
3001 to 4000 Hours	80%	\$42.44
4001 ----- Hours	100%	\$53.05

Upon completion of the term of two (2) years or four thousand (4000) hours whichever occurs later, the Drywall Finishers Apprentice will then step into the rank of Journeyperson.

About the Finishing Trades Institute of DC 14 Chicago

The Finishing Trades Institute of DC 14 Chicago is a two (2) year program sponsored by Painters District Council #14 and the Drywall Contractors who are signatory to an agreement with the Union.

The Apprentices learn the trade while working on the job for Union Wages. Apprentices attend classes for **60 weeks**: one (1) day each week for eight (8) hours as per DOL requirements.
